

Food Industry Sales Association of Northern CA Memorial Scholarship Program

2023-2024

With over 100 years of history, Food Industry Sales Association of Northern California's mission is to provide annual scholarships to Association members as well as Retailers/Wholesales Headquartered in Northern California.

This award for higher education is given to students who exhibit leadership in school, community activities and demonstrate superior scholastic achievement.

The Food Industry Sales Association will award scholarships of \$2,000, \$3,000 for the top applicant, for the 2023-2024 academic school year.

Prospective applicants may apply if attending an undergraduate/graduate course of study in Fall 2023-2024, at an accredited two-or-four-year college, university, or vocational-technical school. This includes those students currently enrolled in an undergraduate course of study and has one or more years of school remaining.

To apply for Food Industry Sales Association Memorial Scholarship, you must complete the application and comply with the application checklist. Copies of the application can be found on our website, http:\\ncfisa.org.

OFFICIAL RULES

In order to be eligible for a scholarship, applicants must work for or be an immediate family member of a company that is a current member of the Food Industry Sales Association of Northern California. Employees or immediate family members of Food Retailer/Wholesalers that are headquartered in the Northern California trade area also qualify. (Immediate family member includes son, daughter, brother, sister, mother, father, niece, nephew, or grandparents, including in-law thereof.)

Applicants must complete the application form in its entirety and return it to FISA by the entry postmark deadline, May 1, 2023. All applicants will be evaluated based on 5 Criteria:

- Scholastic Achievement
- Leadership in Community & School
- Essav
- Clear Statement Education/Career Goals
- Financial Need

FISA will have the sole responsibility for the selection of recipients and its decision will be final.

Recipients will be notified by mail and email. All Federal, State, and local laws and regulations apply. Recipients shall be responsible for any and all taxes. Recipients will be required to sign and return an Affidavit of Eligibility/Release of Liability. Acceptance of scholarship constitutes permission to use recipient's name and/or likeness for purposes of advertising and promotion and agreement to attend a local awards ceremony at the FISA expense. Transfer of the scholarship is not permitted. The award will be paid directly to the registrar at the recipient's school after verification of enrollment. The Funds must be used within a 12-month period from the date announced, exceptions must have FISA board approval and must be in writing.
